### GlobalMobileVision.com: Employee “detained” and staff “underpaid” at IT company

The text below here is an extract from an article from today's [Village magazine](#). You can read the full article [here](#).

It is about a company Global Mobile Vision that “has been accused of intimidating staff and of failing to pay wages due. And its work practices are bizarre”, according to Village Magazine.

I went looking for information about this company. After doing a whois on the name the following was found:

The phone number listed above, does not work.

As stated in the article “The company has no office at its official Dublin address, at 41 Lower Baggot St, but collects its mail from the building every week.”

The company states on their headed note paper that they are registered as company number . This number is not registered with the CRO for any company. Global Mobile Vision does not look like registered as a company. In fact no company is registered with these details at all.

There is a meeting in Buswell's Hotel on Molesworth street tomorrow at 2PM. Several journalists will be in attendance along with some politicians. I am not sure if there will be any techno-journos-if anyone knows any, please let them know.

The main reason I am posting this, is in doing some investigation on this company, there was \*no\* online mention to them whatsoever (apart from 4 inward links, 3 which seem to be removed).

It was very difficult in finding out information about them, save for traditional methods (CRO, Tax Office, etc).

As many posting that can get cached in public the better. The more pages linking here, or mirroring this on the Internet, the better.
